RE: Peddler License Permit Revocation Request

Rosemary Chesney was granted a Peddlers Permit by Waterford Township on May 31, 2022, for peddling associated with the organization Southwestern Advantage. The Waterford Police Department has received citizen complaints concerning Ms. Chesney. She was reported for peddling after 8:00 p.m. in violation of Section 10-490 of the Code of Ordinances. She was also reported violating Section 10-492 for refusing to leave a premises after being directed to do so. Her actions constitute violations to Township Ordinances and the Peddling License.

I am requesting the Township of Waterford serve notice of revocation to Rosemary Chesney with copies to Southwestern Advantage and Jake Chesney, the Contact Person listed on the Peddling License Application.

Below is the revocation process to revoke Ms. Chesney's License.

CHAPTER 10 LICENSES AND MISCELLANEOUS BUSINESS REGULATIONS

Division 2. Guidelines For License Revocation

Sec. 10-122. Notice of grounds for revocation or suspension (synopsis)

- (a) "If a licensed issued by the Township shall become subject to revocation ..the licensee shall be provided with written notice served by personal service, certified mail or other service which provides actual notice of a hearing before the Township Board, with a statement of the reasons and grounds for a revocation or suspension of a license."
- (b) "...The written statement of the reasons and grounds shall contain a statement of factual allegations with sufficient clarity to apprise the licensee of the full nature of transactions or occurrences relied upon... and shall make reference to all provisions of the license and any statute, ordinance or regulation which are alleged to have been violated."
- (c) The notice shall be served upon the licensee no later than (7) days prior to the date set for hearing."

(d) "The notice shall also advise the licensee of the following rights..."

- (1) To the assistance of their own counsel.
- (2) To present questions to be asked of witnesses by the Township Supervisor or acting chairperson at the hearing.
- (3) To request and receive before the hearing copies of all non-confidential reports, files, documents upon which the grounds for the license action are based.
- (4) To produce witnesses and exhibits on their own behalf.

Art. VII, Division 2. General Regulations for Canvassers, Solicitors and Peddlers

Sec. 10-490. Hours for Canvassing, Soliciting or Peddling

No canvassing, soliciting, or peddling shall take place in the Township after 8:00 p.m. or the official sunset, whichever is earlier, or before 9:00 a.m., prevailing time.

Sec 10-492. Request to Leave

No canvasser, peddler or solicitor shall remain on private property after having been asked or directed to leave the premises by any person lawfully in possession of the premises.

Division 4

Sec 10-532

Peddler licenses may be denied, suspended or revoked as provided in Sections 10-079, 10-080 and Division 3 of Article III of this Chapter.

During the past several weeks the Waterford Police Department has responded to complaints about Ms. Chesney on 4 different occasions (see attached Police Reports) and identified violations of the Township Ordinances and Peddler License requirements. The complaints include soliciting after the permitted time period and failure to disclose she was on property for the purposes of peddling.

During that time Rosemary was aggressive with the complainant at this address.

On 6/30/22 [REDACTED] came into the station to file a trouble complaint. Last night (6/29) at 2140 HRS a woman who identified herself as Rosemary came to [REDACTED]' door at [REDACTED]. Upon checking with the Clerk's Office, I learned that there is a Rosemary Chesney registered with them. Rosemary did not present her Waterford Peddler/Solicitor License to [REDACTED]. According to [REDACTED], Rosemary was unclear as to why she was there. She was attempting to gather information about children in the area. Rosemary's behavior was described as bizarre.

Rosemary repeatedly asked to come into [REDACTED] home and was unwilling to accept no as an answer. That behavior, combined with Rosemary's questions about children in the area, caused concern and prompted the request for a police report.

Officers had been dispatched to [REDACTED] yesterday morning as well for a complaint about Rosemary. At that time she was advised of the hours for peddling/soliciting and of areas where it's not permitted (22-19442). I attempted to call Rosemary but the number she had provided went straight to a voicemail box that was full. Additionally, the address that she provided on the prior call was in Georgia whereas the address she provided to the Clerk's Office was in Commerce Township.

Per the Clerk's Office, as the time rules were violated, a copy of this complaint will be forwarded so that Rosemary's Peddler/Solicitor License can be reviewed.
