 - 2.1. Waterford Township has appointed Fire Chief Matthew Nye as the 13th Chief in Waterford Regional Fire Department History. Chief Nye began his career as a firefighter with the Pontiac Fire Department in April 1996 and joined the Waterford team in 2012 when the Waterford Regional Fire Department formed to serve the three communities of Waterford Township, the City of Pontiac, and the City of Lake Angelus. Chief Nye has held the ranks of Firefighter, Paramedic, Engineer, Lieutenant, Captain, Battalion Chief, and now Fire Chief. He comes from a family of first responders, including his great-grandfather, two great-uncles, grandfather, father, and brother, who all worked for the Pontiac Fire Department, and a great-uncle who worked for the Pontiac Police Department
 - 2.2. Waterford Township DPW is performing Spring hydrant flushing as of April 1st, beginning in the North end of the Township and working their way South over the next month. Customers may see brown water from their faucets and/or toilets. Flush it by running cold water in the bathtub or laundry tub until it runs clear. Please contact the Waterford Township Department of Public Works at 248-674-2278 with any questions or concerns.
 - 2.3. GFL curbside yard waste collection began April 1, 2024, and will be collected weekly through the second full week of December on your regular collection day. All bags and containers must be at the curb by 7:00 a.m. on your collection day. For a full list of yard waste details, please visit the Waterford Township website at www.waterfordmi.gov/trash.  - 2.4. Starting April 1, 2024, residents, businesses, and visitors will begin to see trucks from Wachs Water Services (photo attached) throughout the Township completing the DPW Valve Assessment and Exercising Program. The Wachs Water Services crews will be assessing and exercising approximately 3,800 valves in the water distribution system. If required, crews will complete minor repairs on a number of the valves. The valves are located in green belts, easements, and along roadways, usually in wells with manhole covers. The crews may have to close traffic lanes for short periods of time for their safety and the safety of motorists. Patience and understanding would be appreciated. The project is expected to take four to five months. It will start in Section 1 of the Township and continue through each section sequentially. A numbered section map is included below for reference. 
