6. Awards and Presentations

6.1 51st District Court 2024 Report Presented by Jen Thom, Court Administrator

Jen Thom reviewed the 2024 51st District Court Year in Review.

Jen thanked the board for their time in presenting the 2024 year in review. The judges appreciate the funding and support extended to the Court and understand the Township's fiduciary responsibility. Their mission is to run the organization in a way that is accessible, efficient, and timely to those served.

They have jurisdiction over the Charter Township of Waterford and process cases filed from the Waterford Township Police Department, Oakland County Sheriff's Office, Michigan State Police, DNR, Attorney General, and a civil caseload.

Trustee Harris inquired about those with an alcohol problem for those who have lost their driver's license from an old DUI. Participants in a certified sobriety court program can use an interlock device. She welcomed Trustee Harris to contact her.

6.2 Oakland County Commissioner Joliat and State Representative Harris

Oakland County Commissioner Joliat and State Representative Harris addressed the Board of Trustees.

State Representative Harris discussed the Earned Sick Time Act (ESTA) round table at Boomer's with the Michigan Chamber sharing compliance measures. If you have compliance questions, please contact his office at mikeharris@housemi.gov or 517-373-0728.

The bipartisan Ground Emergency Transport law and the WTFD are expected to receive about \$500,000.00. This money helps recoup costs from Medicare patients that our EMS runs on, and it is Federal dollars allocated in the federal system that we get to bring back to us.

They are currently working on the Public Safety and Violence Prevention Fund (HB 4260 and HB 4261). It recently passed the House 104/110. This is the first time Michigan has looked at dedicating funding to law enforcement. This \$115,000,000 is dedicated out of our sales tax revenues to law enforcement across the State of Michigan. There is \$72,000,000 for cities, villages, and townships, and it will be based on violent crime rates. We believe approximately \$261,000 will make its way to the Waterford Township Police Department.

In addition, they are dedicating \$1.5 million in grants for DHHS to deal with community violence intervention to address the root cause of violence, and \$1.5 million will go to the crime victims' rights fund. Oakland County will receive about \$5.8 million out of this fund. He encouraged those to contact their Senators if you would support this.

Oakland County Commissioner Joliat and State Representative Harris Continued.

The State is working on road funding that will dedicate \$3.1 billion extra funding for roads. PA 51 would receive \$1 billion and \$2 billion that would address local road funding. The money would go to the Road Commission for Oakland County to be distributed but it is dedicated funds with no match required. The funds could be used for all roads: residential, secondary, main roads, whatever is worked out with Oakland County.

Trustee Harris clarified PA51 and confirmed that \$2 billion would be used for local roads.

Finally, State Representative Harris met with Supervisor Bartolotta, State Representative Carter, and Senator Runestad and reached out to Senator Moss about the appropriations request for Waterford Regional Fire Station No. 2. The funding request has been submitted. He clarified the new process for appropriations requests and made it more transparent. You may find all of the appropriations requests at house.mi.gov under appropriations request. There are over 4 billion dollars in requests. State Representative Harris clarified that they submitted \$5.8 million was requested and that they will know more in the future.

Trustee Harris inquired how the balance of a new fire station would be paid for. He was advised that Grant Writer John Lyman is working on additional grant requests, and reserve monies have already been set aside.

Oakland County Commissioner Joliat discussed the Road Commission's new building on Pontiac Lake Road, and they have received grant money from the State and Federal government. They have planned to consolidate both RCOC buildings and build a new building for the past 10 years. The RCOC reports to the State per PA 51, and the County cannot tell them what to do. There are three appointments appointed by the party in power (Executive Coulter). They are supposed to be fiduciaries of the Road Commission plans. While attending a ribbon cutting last fall, OCC Joliat was advised that all of the dotted lines had been signed, contracts had been issued, the building was started, Waterford Township had about 30k site plan hours in review, and \$5 million invested in the Waterford property. She received a call in February inquiring about why the RCOC new building is being delayed, as the Oakland County Board of Commissioners was cited as a reason for the delay. After looking into it, Executive Coulter and Commissioner Chairman Woodward wanted to look at other options as to where the building could go, and a 3-month pause was approved. She stated this was a significant economic development for Waterford, with 200 jobs for Waterford. The 3- month pause is up on May 22, 2025; when the Commissioners from the Road Commission were pushed, they indicated they are waiting on direction from Executive Coulter for possible opportunities in the City of Pontiac.

RCOC chose the new site for the building because the salt mine and traffic safety center are right there (near the new location). The next meeting is May 14, 2025, at 9:45 a.m. at the Beverly Hills building. If you want to speak during the public comment, you must submit what you want to discuss online. OCC Joliat will share the information with the BOT and on social media. She asked to consider attending to pressure the Commissioners because they are not doing what is fiduciary responsible, and to wait for the County Executive, who has no authority over what they do, is also wrong.

Scott is a retired Police Officer and U.S. Drug Enforcement Administration Agent requested to discuss marihuana in the Township. He was requested to wait until public comment at the end of the meeting.

Trustee Harris said she is a distant relative and plans to vote this evening because he rarely sees her, and she is not an immediate family member. **He also said that he was not involved in the selection of either of these final companies for the architect and construction manager.**, Trustee Harris said SEMCOG may help, and he will reach out to them. **He did not know about this until last week.**, Supervisor Bartolotta said he has formed a group to start putting together a bid proposal for a new waste hauler. **Trustee Harris said he knows the owner of Priority Waste and has requested to be removed from all items, including the team that is working on the bid proposal request for a new waste hauler.** Trustee Harris said he would like to continue the work session meeting minutes, hold them in the auditorium, and videotape them. A roll call vote was taken.

Trustee Gilbert

Discussed the selection of the Construction Manager and Architect/Engineer for the Waterford Community Center. He recommended watching the April 14, 2025, board meeting so as to learn more about the process.

Trustee Hauswirth discussed transparency and shared information on finding what has been available for the residents for years at www.waterfordmi.gov/1458citizensguide.

Clerk Markee

Waterford Township does not have a May 6, 2025, election. Our next scheduled election is August 2026.

Supervisor Bartolotta

Supervisor Bartolotta thanked all of the volunteers on Saturday, April 26, 2025, in support of Earth Day. There were over 100 volunteers and picked up roughly 25 cubic yards of trash. He discussed a variety of projects within the Township including but not limited to: RFP for a Single Residential Waste Hauler, Waterford Community Center, Fire Station No. 2, Marihuana Licenses, Legget Campus, Library remodel, budget and spending, and residential road repair program.

Trustee Wall

Trustee Wall provided a Riverwalk Extension update and recognized those that have donated. The ribbon cutting will be on Saturday, June 28, 2025. Trustee Wall also thanked the local companies that donated to Earth Day Clean-up: McNab's Hardware, Tenuta's Food Market, and Gordon's Food Service.

Trustee Harris

Trustee Harris shared that he volunteered to clean up a park on Saturday, April 26, 2025, in support of Earth day. Trustee Harris read his Facebook post items including work session meetings, community center, waste hauler contracts, marihuana licenses, fire house no. 2, fire department contract, Leggett senior center, Library remodel, budget and spending, and residential road repair program.

He read a March 24, 2025 correspondence from Mark Dunn, Mayor from the City of Troy.

The City of Troy conducts its deliberations on various issues through open meetings, allowing community engagement and participation. Recent discussions have included topics such as city bonding, emergency medical services (EMS) management, and capital improvements. These meetings are held in accessible venues, with a conference room accommodating at least 40 attendees and the Troy Community Center able to host up to 80 people.

The open meetings invite residents to provide input, fostering an interactive dialogue on significant issues affecting the community. Additionally, these sessions are broadcast online, enabling residents who cannot attend in person to follow the discussions remotely and stay informed about the city council's perspectives.

Decisions regarding these matters are ultimately made during formal city council meetings held in the council chambers. At these meetings, all votes are conducted transparently, with the outcomes and related discussions openly shared with the public. This process allows for a clear understanding of how decisions are reached and encourages ongoing community involvement.

He also had letters from residents Gary Biron, David Roszkowski, Kathy Chiaravalli, Eric Hannis, Jake Collins, Noah Goodfellow, Joann Parnell, Rachel Collins, Robert McKinnery, and Tim Campbell in support of keeping the work sessions meetings and broadcasting them.

He wants to have transparency and community involvement, he'd like the invitation for people to volunteer put on the agenda, he wants to be a taxpayer advocate. He doesn't want to run again; he wants to be here for four years and make a difference. He also wants to get involved to repair residential roads. We need community involvement and people want the ability to view the meetings at a later date. He would like to have the work sessions in the auditorium to allow for more people to attend the meetings.

10. New Business**10.1 Board Work Session Schedule**

The following memo was received by Supervisor Bartolotta.

In October 2024 at a regular meeting of the Board of Trustees, the schedule for the 2025 Township Board Meetings, Work Sessions, and Holidays Observed with Office Closings was approved.

10.2 Purchase of Unmarked Police Vehicle

The following memo was received by Police Chief Underwood.

Our Special Operations Unit conducts investigative and surveillance activities on a regular basis. Officers assigned in such a capacity are deployed in unmarked police vehicles.

Currently, at least one of their assigned vehicles is approaching 100,000 miles. Our intention is to transition that vehicle out of our fleet, replace it with new, and sell the old.

We have identified the model that fits our needs best, and that model is offered at government pricing in the State of Michigan (MIDeal) vehicle contract at the price of \$41,664.00. In an effort to expedite delivery we checked with three local dealers regarding inventory and pricing. While two of the local dealers quoted the vehicle higher than the price in the MIDEAL contract, Serra CDJR quoted a lower price than the MIDeal contract and have the vehicle in stock.

The proposed purchase is as follows:

10.3 Phase 3 of ARPA Sidewalk Improvements Project - Loop; Highland Road, Elizabeth Lake Road, Cass Lake Road, and Pontiac Lake Road

The following memo was received by Jeffery Polkowski, Director of Development Services.

DLZ has been selected by the Board as the engineering firm to design replacement sidewalks for Phase 3 of the M-59 Sidewalk Improvement project along Highland Road, Elizabeth Lake Road, Cass Lake Road, and Pontiac Lake Road. The project scope consists of removal and replacement of existing deteriorated asphalt and concrete sidewalk with new concrete sidewalk, curb and gutter, driveways, restoration, and associated work. On April 10, 2025 at 2:00 pm, a total of five bids were received for this project. They are as follows in the order that they were opened:

Phase 3 of ARPA Sidewalk Improvements Project - Loop; Highland Road, Elizabeth Lake Road, Cass Lake Road, and Pontiac Lake Road Continued.

Contractor	Total Bid
Audia Concrete Construction, Inc.	\$597,994.60
Italia Construction, Inc.	\$490,421.64
BKJ Construction LLC	\$450,997.00
Prime Construction and Excavation	\$421,880.00
Great Lakes Contracting Solutions, LLC	\$565,000.50

While the most competitive bid was submitted by Prime Construction and Excavation with an as-read bid value of \$421,880.00, the bid was reviewed, and it was determined that a mathematical error in one of the pay items reduced their overall bid to \$405,113.44.

The Contractor was contacted about this discrepancy and agreed to complete the Contract at the correct as-bid unit prices. An engineer's estimate of construction costs was created by DLZ with an estimated total construction cost of \$570,173.00. This analysis revealed **an immediate savings of \$16,767.00 along with a total project savings of \$165,059.56** when compared to DLZ's original estimated construction cost.

After reviewing the letter of recommendation from DLZ, I would like to recommend that the Board award this contract to Prime Construction and Excavation in the amount of \$405,113.44 per unit prices listed on the bid for this sidewalk reconstruction project. They provided several professional references for similar recent projects. DLZ contacted several of the references and received good reviews on both the Contractor's workmanship and communication.

Along with this contractor proposal is DLZ's proposal to the Township for construction engineering services including Crew Days, Construction Engineering and Contract Administration in the amount of \$30,400.00..

DLZ has also recommended a 10% contingency (\$40,512) be added to this project, should any unforeseen change orders arrive. Staff agrees with this assessment.
