6. INTRODUCTION**6.1 Rezoning Case No. 17-11-03, Skipper Properties, LLC, Located at the Southeast Corner of Cass Elizabeth Road and Parkway, Parcel No. 13-35-301-001**

The following memo was received from Larry Lockwood, Superintendent of Planning and Zoning.

This rezoning application by Skipper Properties, LLC, is a request to rezone the above referenced property from C-2, Small Business District to CR, Commercial Recreation District. The subject property, which was formerly known as the Tomato Kitchen carryout restaurant, has since been demolished. The property was recently purchased in combination with adjacent Sun & Ski Marina property in order to provide for a redevelopment of the marina to a more modern and efficient marina facility.

Zoning History: 1950 – 1960: Recreation 1
1960 – 1963: Commercial 1
1963 – 1981: RA-2, Commercial Recreation
1981 – 2010: C-2, General Business
2010 – Present: C-2, Small Business

Master Plan: The Master Plan for the subject property shows Community Business. During the last Master plan update in 2003, the subject property (0.26 acres) was identified as community business as a “stand alone” parcel. The Master Plan designation for the adjacent Sun & Ski Marina property is currently shown as Multiple Family residential.

The Planning Commission reviewed this rezoning application at their December 12, 2017 meeting and resolved 6-0 (with Commissioner Reno absent) to forward a favorable recommendation for the request to rezone from C-2 to CR on to the Township Board (please see attached meeting minutes).

Based upon the Planning Commission’s favorable recommendation in this rezoning case, if the Board wants to consider adopting the requested rezoning to CR, Commercial Recreation District, the appropriate motion would be to introduce the ordinance and schedule it for possible adoption at the January 22, 2018 meeting.

However, if the Board does not want to adopt the requested rezoning, the appropriate motion would be to not introduce the ordinance and deny the rezoning.

6.2 Rezoning Case No. 17-11-04, Vacant Property Located on Rural Street, East off Dixie Highway, Parcel Nos. 13-04-253-013 and 13-04-253-014

The following memo was received from Larry Lockwood, Superintendent of Planning and Zoning.

This rezoning application by Tom Wilhelm, is a request to rezone two (2) platted acreage lots on Rural St. from R-1, Single Family Residential to R-1E, Single Family Attached Residential. As you may recall, Mr. Wilhelm had presented an initial rezoning request in November to rezone the subject property to the R-1E, Single Family Attached district. That case (17-10-02) was not supported by the Planning Commission and subsequently not supported by the Township Board.

Zoning History: 1950 – 1960: Residential I

1960 – 2010: C-2, General Business

2010 – Present: R-1, Single Family Residential

Master Plan: The Master Plan for this property shows single family residential. This designation provides for a limited range of single family density classifications, from a low density of one dwelling unit per acre to a high density of 5.5 dwelling units per acre.

The subject lots 13 & 14 are part of the Waterford Farms subdivision along Rural St. which was established in 1940. At that time, the original intent was to provide larger lot sizes of one (1) acre or greater, for residential development and associated small farm activities.

R-1B, Single Family Residential District (please see attached draft meeting minutes).

7.3 Cemetery Care Fund Balance Designation Resolution

The following memo was received from Derek Dietrich, Township Budget Director and DPW Administrative Superintendent, and Barb Miller, Assistant Budget Director and Accounting Manager:

On November 27, 2017 the Waterford Township Board approved revisions to the Cemetery Care Ordinance. In turn, the fund balance designation for the Cemetery Care Fund needs to be revised so that it aligns with the changes made to the ordinance.

It is recommended that the 'Committed' Cemetery Care Fund revenue of \$64,000, as represented by revenue from Cemetery Care Sales for the period February 2007 to November 2017, be moved from the 'Committed' designation to the 'Non-Spendable' designation by the attached resolution. In the past, the intent of the Cemetery Care Sales revenue (February 2007 to November 2017) was for perpetual purposes and will be 'Non-Spendable' funds. The intent of future Cemetery Care Sales revenue (after November 2017) will be for expenditures related to maintenance, construction, and general upkeep of the Townships' Municipal Cemeteries and will be 'Committed' funds.

7.4 Liqui-Force Services Purchase

The following memo was received from Russell Williams, DPW Director:

Liqui-Force Services has been working with Waterford Township for many years on a continuous effort to rehabilitate aging sewer pipe with a "No Digg" technology that saves the township countless dollars as compared to an excavation of a length of sewer main for a repair.

At the May 22, 2017 Board Meeting action was taken to extend Liqui-Force Services unit pricing contract through 2019.

I have attached an invoice in the amount of \$193,531.80 from Liqui-Force Services for sewer main rehabilitation services in 2017. This is a budgeted expense. Now, I would also request approval for a not to exceed purchase of \$250,000.00 sewer main rehabilitation services for the 2018 budget year. This is also budgeted expense.

7.5 Hydrocorp Cross Connection Commercial Inspections Contract 2018-2020

The following memo was received from Russell Williams, DPW Director:

I have attached a proposal in the amount of \$110,412.00 (\$36,804.00 annually) from Hydrocorp, previously Hydro Designs, to perform 36 months of professional services in support of Waterford Township Department of Public Works' (DPW) Cross Connection Program (see Exhibit A). This proposal represents an extension of an existing

professional services agreement with Hydrocorp, including a **4%** increase in the cost. This is the first increase since the 2011 contract. Joseph Ashley prepared a memo describing Hydro Designs' role and recommending acceptance of their proposal (see Exhibit B).

The DPW is required, under the provisions of the Safe Drinking Water Act (SDWA), to perform cross connection inspections of its commercial and industrial customers. A cross connection describes a condition in which the public water system is placed in jeopardy due to flow reversal of the customer's water service. The flow could be reversed when the water pressure of the public water system is exceeded by the water pressure of the customer's system. There are devices and plumbing requirements utilized to prevent this situation from occurring.

Hydrocorp has been providing cross connection services to the DPW since 2005. Under the supervision of the DPW, Hydro Designs annually:

- Coordinates with hundreds of customers to perform on-site inspections,
- Performs inspections (both initial and follow-up) and either certifies compliance or issues corrective action requirements to customers,
- Prepares and submits required SDWA compliance documentation to the Michigan Department of Environmental Quality.
- Assists the DPW with public relations and in educating its customers on the requirements of the SDWA.

I am requesting that the Board recognize Hydro Designs as Waterford Township's Single Source vendor for cross connection services and award a contract to Hydro Designs to perform cross connection program professional services.

7.6 Hydrocorp Cross Connection Residential Inspections Contract 2018-2020

The following memo was received from Russell Williams, DPW Director:

I have attached a proposal in the amount of \$146,340.00 (\$48,780.00 annually) from Hydrocorp, to perform 36 months of professional services in support of Waterford Township Department of Public Works' (DPW) Cross Connection Program (see Exhibit A). This proposal represents a new MDEQ program to continue to protect public water systems. With this new program, a decision was made to keep commercial accounts program separated from residential accounts during the initial phase to track cost more effectively. This being a new program that could continue to grow as more irrigation systems, private wells, inground pools and spas are included, it is important we track those cost and decide how to best fund the program moving forward.

The DPW is **NOW** required, under the provisions of the Safe Drinking Water Act (SDWA), to perform cross connection inspections of its residential customers. A cross connection describes a condition in which the public water system is placed in jeopardy

due to flow reversal of the customer's water service. The flow could be reversed when the water pressure of the public water system is exceeded by the water pressure of the customer's system. There are devices and plumbing requirements utilized to prevent this situation from occurring. These devices need testing and inspections to insure performance and protection of the public water system (see Exhibit B).

Hydrocorp has been providing commercial cross connection services to the DPW since 2005. Under the supervision of the DPW, Hydrocorp annually:

- Coordinates with hundreds of customers to perform on-site inspections,
- Performs inspections (both initial and follow-up) and either certifies compliance or issues corrective action requirements to customers,
- Prepares and submits required SDWA compliance documentation to the Michigan Department of Environmental Quality.
- Assists the DPW with public relations and in educating its customers on the requirements of the SDWA.

I am requesting that the Board recognize Hydrocorp as Waterford Township's Single Source vendor for cross connection services and award a contract to Hydrocorp to perform residential cross connection program professional services.

I have attached a proposal from Peerless Midwest to perform maintenance and rehabilitative services on Waterford's production wells and pumps.

Peerless Midwest has been Waterford's sole provider of well consulting/contracting services since 2009. They have completed dozens of inspections and reports and have annually provided services on Waterford's production wells. The scope of their work has included drilling, testing, inspection and making repairs.

Please note that these are all not-to-exceed estimates, and that Waterford will only be invoiced for the actual work completed.

I am requesting that the Board recognize Peerless Midwest as Waterford Township's Single Source vendor for water well services and award a contract to Peerless Midwest to carry out the production well and pump services.

7.8 PUBLIC COMMENTS

Mark Leopold, 4717, Motorway

Mr. Leopold addressed the recent petition for SAD Improvement of County Roads in Elizabeth Lake Golf and Country Club Summer Home Sites Subdivision (Motorway, Westlawn Parkway and Lodi) and expressed his opinion that the petition and subsequent action by the Road Commission were based on incorrect and misleading information and therefore, they will be circulating a petition for discontinuance of this proposal. Per the Road Commission, there are only two ways to achieve a discontinuance; one requires the residents to file a discontinuance petition, the other is for the Township Board to rescind the motion they made on November 13, 2017.

Dale Leopold, 4717 Motorway

Mrs. Leopold stated that she is the Secretary of the North Shore Elizabeth Lake Association and read a letter from their President Rochelle Denipoti (4451 Motorway) who was unable to attend the meeting. It was stated the petition circulator misrepresented the facts when obtaining resident's signatures and that the petition was not circulated on behalf of their association.

John Soullier, 4590 Motorway

Mr. Soullier stated that in the November meeting, it was erroneously stated that he was moving and therefore had no vested interest in the SAD. Mr. Soullier stated he has only resided here for 17 months and has no intentions of moving.

Mike Thielen, 4745 Motorway

Mr. Thielen stated that the first and second petitions failed and expressed his opinion that whole project was been misrepresented to the Board and the information provided to the Board

contained errors. Errors should be acknowledged and the residents would like the opportunity to explore alternatives to the project as proposed.

Margaret Thielen, 4745 Motorway

Mrs. Thielen stated that she is the originator of the petition for discontinuance and expressed her opinion that it is not right to make the residents responsible for petitioning for a discontinuance when the original decision to proceed with the SAD was based on misinformation.

Treasurer Birch stated that she had received a call from Mr. John Palazzo, resident of 4385 Motorway. Mr. Palazzo asked that the Township Board rescind their resolution regarding this SAD and allow the residents to investigate alternatives.

Michael Keith, 4580 Motorway

Mr. Keith stated that he had signed the original petition but based on what he now understands, he wishes to rescind his signature and has several concerns with the proposal.

Trustee Bartolotta stated that he will be bringing this issue to the January 22, 2018, meeting with the intent to rescind their November 13, 2017, SAD resolution.

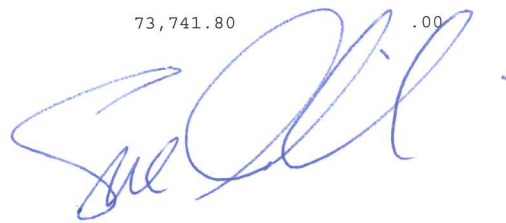
