**Supervisor Wall**

This past Saturday was the 32<sup>nd</sup> Meals on Wheels Walk and Roll at the Waterford Senior Center. Over 70,000 meals are served to home bound seniors in Waterford Township. There are another 500 holiday meals served on Thanksgiving and Christmas cooked by Pops, Green Apple, and The Royal Diner; they prepare the meals, and our drivers deliver the meals on the holidays. In addition, 13,000 meals are served on-site at the Waterford Senior Center. The Waterford Senior Center annual budget is \$429,000 a year. There are 60 volunteers that contribute 15,000 hours a year preparing, packaging, and delivering the meals. This past Saturday approximately 250 people attended the event, and 145 local businesses and individuals sponsored the event.

**C.** The Applicant has a Township Medical Marihuana Facility License. The Application for an Adult Use Marihuana Establishment was reviewed by Township personnel as provided in Section 10-321(a).

**D.** Based on the reviews and determinations made by the Clerk, the Public Works Official, the Treasurer, Assessor and Code Enforcement Officer, the Application was in compliance with the minimum requirements of Section 10-318(3) and (4).

**E.** Based on these determinations, the Clerk's Office notified the Zoning Official that the Planning Commission could proceed with a site plan review of the Planning Division application for a change of use as provided in Zoning Ordinance Section 4-004.1.

**F.** The Planning Commission completed their review of the MJ Highland Planning Division application on September 12, 2023, and provided their recommendation to the Board of Trustees to approve the change of use for the subject parcel #13-13-426-023 from a sole Medical Marihuana Provisioning Center to a mixed-use Medical Marihuana Provisioning Center and Adult Use Marihuana Establishment. The Board of Trustees agreed with the findings and conclusions of the Planning Commission under the Zoning Ordinance and on September 25, 2023, approved the change of use request.

## 6.2 Oakland County Interlocal Agreement - Early Voting Centers

The following memo was received by Clerk Markee.

Proposal 2022-2 was passed by the voters of Michigan on November 8, 2022. This proposal gives Michigan Voters new constitutional rights including voting early where voters will place their ballot into a tabulator like they do on Election Day for nine days prior to Election Day. The Early Voting Center (EVC) will need voting booths, tabulators, printers, and workers which will require a substantial amount of money.

Waterford Township could reduce these costs by coordinating with Oakland County and The City of Lake Angelus. Oakland County will provide tabulators, printers, early voting poll book laptops, and other necessary voting equipment and supplies. The labor costs for nine days, eight hours per day, would be split between Waterford Township paying 80% and The City of Lake Angelus paying 20% given that Waterford Township has 59,598 registered voters and The City of Lake Angelus has 322 registered voters.

The current planned locations for the Early Voting Centers are The Waterford Township Library and The Waterford Oaks Activity Center (as the County backup facility). If the Board of Trustees agrees to enter into this interlocal agreement with Oakland County, please make the following motion:

Attached please find an affidavit signed by the authorized representative from GFL Environmental, USA detailing this request as required by the code of ordinance.

In addition to these delinquent amounts totaling \$739,840.93, a six (6%) percent penalty will also be included per the above-referenced ordinance. The delinquent amount will likely be slightly less due to adjustments, corrections, and payments made between the time the report was generated and final numbers are submitted to the Treasurer for the transfer.

Adoption of the attached resolution will approve the tax transfer request for delinquent charges and 6% penalty and authorize the Waterford Township Treasurer to have the amount transferred to the Oakland County Tax system for inclusion on the tax roll and 2023 Winter tax bill for those addresses with delinquent billings.

Delinquent Residential Waste Hauler Billings Request For 2023 Winter Tax Transfer Continued.**RECITALS**

- A. Pursuant to Waterford Code of Ordinances Section 9-067 **Delinquent charges inclusion on tax bills and tax roll**, GFL Environmental USA, the designated residential waste hauler servicing Waterford Township municipal residential customers, has requested that the Township place the amount of delinquent invoices and late payment penalties for each residential premises that have not been paid, on the tax roll and December tax bill as provided in Section 1-014 of the Code of Ordinances.
- B. Delinquent charges subject to inclusion on tax bills and the tax roll include amounts due by July 1, 2023, for service periods including October 1 to December 31, 2022; January 1 – March 31, 2023; April 1 – June 30, 2023; and July 1 – September 30, 2023. Residents with delinquent balances were supplied with at least four invoices, and delinquent charges are now nearly 90 days delinquent.
- C. Attached to this resolution is an affidavit signed by the authorized representative from GFL Environmental, USA detailing the transfer of delinquent charges to the tax roll as required by the Waterford Township Code of Ordinances.
- D. Per Section 9-067 of the Waste Materials and Residential Single Hauler Ordinance Amendment, a six (6%) percent penalty on those amounts will also be included for collection as any other real property tax.

#### 6.4 Request to Approve Michigan Indigent Defense FY 2024 Grant Contract

The following memo was received by Ms. Ahsley Johnson, Michigan Indigent Defense Commission Coordinator.

The Township of Waterford has been awarded a total authorized Budget of \$771,968.42 for the MIDC Fiscal Year (FY24), which runs October 1, 2023 to September 30, 2024. The State FY24 MIDC Grant Contribution is \$739,912.24; the Local Share Contribution is \$32,056.18. This grant contract only utilizes the funds provided under the grant.

At this time, formal approval of the MIDC FY24 Grant Contract and budget is sought. Attached to this memo is exhibit A, Fiscal Year 2024 Grant Contract.

The Court worked closely with the MIDC to derive the FY24 MIDC Budget, and the Court is satisfied that the appropriation will meet indigent defense needs.

As such, the following resolution is respectfully recommended for the Township's consideration:

- WHEREAS, The MIDC Act requires the Township of Waterford to create an annual compliance plan and cost analysis required to deliver indigent defense services in compliance with the approved MIDC standards, MCL 780.993(3).
- WHEREAS, The MIDC Act requires the MIDC to appropriate funds and provide grant monies to local funding units for the costs in excess of the local share to continue to provide indigent defense services that comply with the minimum standards established by the MIDC, MCL 780.993(6).
- WHEREAS, The grant award funds the following position within 51st District Court: one (1) MIDC Coordinator, one (1) Managed Assigned Counsel.

**6.5 Update Sidewalk Replacement Scope Along M-59**

The following memo was received by

The Michigan Department of Transportation (MDOT) through their consultant OHM has been designing access management proposals along the M-59 corridor from Tilden Avenue to Elizabeth Lake Road. MDOT has hired OHM to perform site visits to evaluate each potential access management location and to assess the properties from an operational standpoint, provide recommendations, and oversee the construction of this project. The MDOT project will rehabilitate sidewalks that are intersections, by signals and through driveways.

Because this stretch of M-59 happens to be the sidewalks in the worst condition throughout the Township, as per the PASER study completed in 2017, the Development Services Department saw this as an opportunity to piggyback off of MDOTs efforts and partner with their contracted sidewalk crew to design sidewalk replacements at a much lower rate than if the Township were to go out to bid on their own.

In November of 2022 the Board of Trustees approved OHM via MDOT, as the vendor for the engineering work to design replacement sidewalks for this project for \$20,774 utilizing ARPA monies. The Township project will address the portion of sidewalks that will not be covered by MDOT's project. OHM will design the specification and bids for the sidewalk reconstruction work.

Update Sidewalk Replacement Scope Along M-59 Continued.

Since the MDOT project is currently scheduled for 2026 construction, staff recommends the Township proceed with the sidewalk work under a separate contract with OHM that will allow construction to take place in 2024. While a portion of this design work has already been completed, this would require the Township to enter into a separate Scope of Service agreement with OHM.

It is also important to point out that this is a slight cost increase from \$20,774 to \$22,500 in order to extend this sidewalk work from Tilden Avenue to Telegraph Road, completing this segment of M-59

After reviewing the Scope of Services by OHM, I would like to recommend that the Board approve the Scope of Services with OHM, for this sidewalk reconstruction project. They responded with a quote that both meets our anticipated budget and addresses all of our goals and objectives.

- 1. Approve OHM as the vendor for the M-59 Sidewalk Replacement Project for the amount of \$22,500.**
- 2. Approve an addition of \$1,726 to expense account number 28290-97005-ARPA1 for the M-59 Sidewalk Replacement Project.**
- 3. Authorize the Supervisor to sign the agreement with OHM for professional services to design the specifications and bids for the sidewalk project.**

**6.6 Special Assessment District for a Canal Dredging Project in Maceday Lake and Related Services**

The following memo was received by Mr. Jeffery Polkowski, Development Services Director

The Development Services Department has received the enclosed petition from residents owning property along canals within Maceday Lake that also front on Maiden Street, Iris Drive, Rich Drive, Austinwood Court, Parkwood Court, as well as several homes at the end of these canals on Maceday Lake Road near the northwesterly end of the lake in order to establish a Special Assessment District (S.A.D.) to fund a canal dredging project in accordance with Act 188 of the Public Acts of 1954, as amended

Special Assessment District for a Canal Dredging Project in Maceday Lake and Related Services

The Development Services Department has reviewed the enclosed petitions recently submitted by the group and has verified that signatures representing 88% of the total land area within the proposed district determined to benefit from such a program are in favor of moving forward with the S.A.D. process.

For the Board's benefit, Act 188 states that if a petition is required by the Board for this type of improvement, then it shall contain the signatures of record owners representing more than 50% of the total land area within the proposed special assessment district as finally established by the Board. Further, Waterford Township's own policy, initially instituted for road improvement projects and now used for all requests received under this statute, stipulates that a petition shall have signatures representing at least 60% of the qualifying criterion as defined in the act prior to any further consideration. Due to the complexity of the work typically involved in preparing preliminary plans and subsequently establishing an estimated cost for such improvements, the 60% threshold was established as a safeguard to protect against losing the preliminary investment made by the Township towards the establishment of an S.A.D. on behalf of petitioners.

Per Act 188, the Township can only recoup these preliminary costs associated with the making and or financing of an S.A.D. if said S.A.D. is finally established. If the Board determines that the petitions presented comprise a sufficient number of property owners, the next step in the process is for the Board to direct Township staff to issue a Request for Proposals ("RFP") to provide plans and a cost estimate of the cost of dredging these canals within Maceday Lake. Once the RFP responses have been received, staff is required to file the cost estimates with the Clerk. The Clerk is responsible for providing the responses with the plans and specifications for dredging these canals to the Board to determine whether it tentatively wishes to proceed with the improvement and to tentatively designate an S.A.D.
