- 106 LF of helix auger pile supported 8 ft. wide timber boardwalk; 8 ft. wide HMA pathway; and 50 LF of five ft. high segmented block wall and accessories; hand railing and reinforced concrete retaining wall; Lump Sum
- 210 SYD HMA approach parking and walkway surface, Unit Price
